#### 1 -Introduction

We respect the privacy of everyone who visits this website. As a result we would like to inform you regarding the way we would use your Personal Information. By submitting your Personal Information to us, you will be treated as having given your permission – where necessary and appropriate – for disclosures referred to in this policy. By using this web site, you acknowledge that you have reviewed the terms of this Customer Privacy Notice and Consent to Use of Personal Information (the "Customer Privacy Notice and Consent") and agree that we may collect, use and transfer your Personal Information in accordance therewith. If you do not agree with these terms, you may choose not to use our site, and please do not provide any Personal Information through this site. This Customer Privacy Notice and Consent forms part of our site Terms and Conditions of Use and such shall be governed by and construed in accordance with the laws of South Africa. This notice explains how we obtain, use and disclose your personal information, as is required by the Protection of Personal Information Act, 2013 ("POPI"). At SIS we are committed to protecting your privacy and to ensure that your Personal Information is collected and used properly, lawfully and openly.

#### 2 -Who we are

SIS manufactures, markets and sells various lifting, lashing, recovery, safety and webbing equipment, amongst other things, in South Africa as well as internationally. POPI requires SIS to inform their clients as to the manner in which their personal information is used, disclosed and destroyed. SIS guarantees its commitment to protecting its client's privacy and ensuring that their personal information is used appropriately, transparently, securely and in accordance with applicable laws. This Policy sets out the manner in which SIS deals with their client's personal information and stipulates the purpose for which said information is used. #### 3 -The information we collect

#### 6 -Personal Information Security

We will, on an on-going basis, continue to review our security controls and related processes to ensure that your Personal Information is secure.
